The method of payment will be cash or managers cheque made payable to Jamaica Social Investment Fund.

All bidders must be tax compliant at bid opening. **The original Tax Compliance Certificate (TCC) must be presented at the bid opening or within two (2) days of the bid opening.**

Bids must be delivered to the address below by **12:00 noon on Tuesday, April 15, 2008**. All bids must be accompanied by a bid security of **\$40,000.00** in the form specified in the Bidding documents. Late bids will be rejected. Bids will be opened in the presence of bidders' representatives who choose to attend at the address below at **12:05 p.m. on Tuesday, April 15, 2008**.
