FRANKLYN TOWN SPORTS COMPLEX - KINGSTON

The Franklyn Town Benevolent Society has received funding from the Jamaica Social Investment Fund/ OPEC Fund for International Development and it intends to apply a part of the proceeds of this grant to cover payments under the following contract:

Franklyn Town Benevolent Society now invites sealed bids from eligible bidders for the proposed **Franklyn Town Sports Complex Rehabilitation & Expansion**. The works involve:

1. Increasing the bathroom space by creating two (2) changing rooms – each of which will have two (2) shower stalls, two (2) toilets and a urinal;
2. Installation of outdoor lights using timber poles;
3. Building a multi-purpose court.

The construction period is **three (3) months**.

FLUCTUATIONS IN INPUT COSTS ARE NOT PERMISSIBLE.

All national bidders must be registered with the National Contracts Commission (NCC) in the category **“Building Construction ” in Grade 3 or higher.**

Bidding will be conducted through the Competitive Bidding Procedures specified in the OPEC Fund for International Development *Procurement Guidelines under Loans extended by the OPEC Fund, November 2, 1982*, and is open to all bidders from eligible source countries as defined in the guidelines and in accordance with tender procedures and guidelines specified in the Handbook of Public Sector Procurement Procedures (May 2001), National Contracts Commission, Sections 3 and 6.

Interested eligible bidders may obtain further information from and inspect the bidding documents at the Jamaica Social Investment Fund’s office at the address below from 9:00 a.m. to 4:00 p.m. Bid collection period is **Monday June 23, 2008 to Monday July 7, 2008**. A complete set of bidding documents in English may be purchased by interested bidders at the address below upon payment of a non-refundable fee of **JA\$2, 000.00** each. The method of payment will be cash or managers cheque made payable to Jamaica Social Investment Fund.

All bidders must be tax compliant at bid opening. **The original Tax Compliance Certificate (TCC) must be presented at the bid opening or within two (2) days of the bid opening.**

Bids must be delivered to the address below by **12:00 noon on Tuesday July 8, 2008**. All bids must be accompanied by a bid security of **\$50,000.00** payable to **Jamaica Social Investment Fund** in the form specified in the Bidding documents. Late bids will be rejected. Bids will be opened in the presence of bidders’ representatives who choose to attend at the address below at **12:05 p.m. on Tuesday, July 8, 2008**.
