1. The Government of Jamaica has received a loan from the International Bank for Reconstruction and Development toward the cost of the *INNER CITY BASIC SERVICES FOR THE POOR PROJECT*, and it intends to apply part of the proceeds of this loan to payments under the following Contracts:

Bucknor Road Works – Phase 1 – Clarendon (#71847)

The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for **Bucknor Road Works – Phase 1 in Clarendon**. This involves the resurfacing of 720m of roadway using 38mm thick asphaltic concrete. Other associated works include Excavation & Earthworks, Road Grading, Provision of Marl Base prior to resurfacing and providing, laying and testing of PVC Schedule 40 water pipes and construction of 526m of 900mmx600mm U-drain. The delivery/construction period is **Fourteen (14) weeks**.

All Bidders must be registered with the National Contracts Commission (NCC) at the time of bid opening in the category “**General Road Works**” in **Grade 3 or higher Grades**. (See www.ocg.gov.jm).

This involves the resurfacing of 810m of roadway using 38mm thick asphaltic concrete. Other associated works include Excavation & Earthworks, Road Grading, and Provision of Marl Base prior to resurfacing and providing, laying and testing of PVC Schedule 40 water pipes. The delivery/construction period is **Fourteen (14) weeks**.

The works involves the construction of a hard court including paving and markings, walkway construction and supplying and installing of play equipment. The delivery/construction period is **Ten (10) weeks**.

7. Bids must be delivered to the address below at or before **Friday, March 28, 2008 at 12:00 noon**. Electronic bidding *shall not* be permitted. Late bids will be rejected. Bids will be opened physically on **Friday, March 28, 2008** in the presence of the bidders’ representatives who choose to attend in person at the address below at **12:05 p.m.**
