The Government of Jamaica has received a loan from the International Bank for Reconstruction and Development toward the cost of the **HURRICANE DEAN EMERGENCY RECOVERY LOAN PROJECT**, and it intends to apply part of the proceeds of this loan to payments under the following Contract:

The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for **Dias Health Centre – Hurricane Dean in Hanover**. The works involve the demolition and alteration works, repairs to timber-framing roof, ply-board ceiling. Supply and installation of doors; execution of electrical and plumbing works; construction of tank base and tank installation; painting of the building and reinstatement of roadway. The delivery/construction period is **three (3) months**.

FLUCTUATIONS IN INPUT COSTS NOT APPLICABLE.

All Bidders must be registered with the National Contracts Commission (NCC) at the time of bid opening in the category “**Building Construction**” in **Grade 4 or higher Grades**. (See www.ocg.gov.jm).

Bidding will be conducted in accordance with the World Bank’s procedures specified in the World Bank’s *Guidelines: Procurement under IBRD Loans and IDA Credits*, and is open to all bidders from Eligible Source Countries as defined in the guidelines and in accordance with tender procedures and guidelines.
