1. The Government of Jamaica has received a loan from the International Bank for Reconstruction and Development toward the cost of the *INNER CITY BASIC SERVICES FOR THE POOR PROJECT*, and it intends to apply part of the proceeds of this loan to payments under the following Contracts:

FEDERAL GARDENS TOWN INTEGRATED INFRASTRUCTURE PACKAGES 1-5 ST. ANDREW (#72146 TO 72150) (Bidders have the option to purchase any number of packages)

The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for *FEDERAL GARDENS INTEGRATED INFRASTRUCTURE PACKAGES 1-5 - ST. ANDREW*. The scope of works for each package involves: **Water Supply** - The excavation and earthworks, laying of approximately 230 metres of 100mm water supply pipe with lot connections and hydrant. **Sewer** - The excavation and earthworks, laying of approximately 230m of 200mm sewer pipes with laterals connections. Construction of manholes. **Road Works** - Reinstatement of pavement to include 150mm thick marl base and 38mm thick asphaltic concrete. Also rehabilitation of storm drains, construction of concrete pavement/sidewalk and repairing hydrants. The delivery/construction period for each package is **Three (3) months per package**.

All Bidders must be registered with the National Contracts Commission (NCC) at the time of bid opening in the category “**Civil Engineering**” and/or “**Pipe Laying**”, and/or “**General Road Works**” in **Grade 4 or higher grades**. (See www.ocg.gov.jm).

The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for **Jones Town Integrated Infrastructure Package St. Andrew**. The scope of works involves the excavation and earthworks, laying of approximately 3000 metres of 100mm water supply pipe network. Associated reinstatement of pavement to include 150mm thick marl base and 38mm thick asphaltic concrete. Provision of approximately 160 No. lot connection consisting of 20mm diameter PVC schedule 40 pipes with average length of 6.5. Also marl filling, rehabilitation of storm drains, construction of concrete pavement/sidewalk and repairing hydrants. The delivery/construction period is **six (6) months**.

All Bidders must be registered with the National Contracts Commission (NCC) at the time of bid opening in the category **“Civil Engineering” and/or “Pipe Laying”** in **Grade 2 or higher grade**. (See www.ocg.gov.jm).

Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits*, and is open to all bidders from Eligible Source Countries as defined in the guidelines and in accordance with tender procedures and guidelines specified in the Handbook of Public Sector Procurement Procedures (November 2008), National Contracts Commission, Sub-Section No. S-2040
