The Government of Jamaica established the Jamaica Social Investment Fund Project to assist in its poverty eradication programme. The Government intends to apply part of the funds it has provided for the cost of the Social Investment Fund to cover payment under the contract for the following projects.

Gordon Town Sports Complex Rehabilitation – St. Andrew (#71476)

Jamaica Social Investment Fund now invites sealed bids from eligible bidders for the proposed **Gordon Town Sports Complex Rehabilitation**. The works involves expansion of the bathroom facilities to create two changing rooms, each of which would have two shower stalls, two toilets and a urinal. Repairs of perimeter fence and building of a multipurpose court. The construction period is **three (3) months**.

All national bidders must be registered with the National Contracts Commission (NCC) in the category “**Building Construction**” in **Grade 4 or higher grades**.

McCooks Pen Integrated Community Space Rehabilitation – St. Catherine (#71289)

Jamaica Social Investment Fund now invites sealed bids from eligible bidders for the proposed **McCooks Pen Integrated Community Space Rehabilitation**. The works involves construction of changing rooms, spectator stands and a perimeter fence around the recreational facilities. The construction period is **four (4) months**.

All national bidders must be registered with the National Contracts Commission (NCC) in the category “**Building Construction**” in **Grade 4 or higher grades**.

All bidders must be tax compliant at bid opening. **The original Tax Compliance Certificate (TCC) must be presented at the bid opening or within two (2) days of the bid opening.**

Bids must be delivered to the address below by **12:00 noon on Wednesday, April 25, 2007**. All bids must be accompanied by a bid security of **\$50,000.00** in the form specified in the Bidding documents. Late bids will be rejected. Bids will be opened in the presence of bidders' representatives who choose to attend at the address below at **12:05 p.m. on Wednesday, April 25, 2007**.
