The Ministry of National Security has received funding from the Inter-American Development Bank and the Department for International Development to implement the Citizen Security and Justice Programme II and it intends to apply part of the proceeds of this funding to cover payments under the following contract:

Jamaica Social Investment Fund now invites sealed bids from eligible bidders for the proposed **Parade Garden Community Centre Rehabilitation Project**. The works involve the demolition of the existing building approximately 323sq.m, construction of new 150mm thick reinforced concrete block wall structure, timber roof frame with shingle as roof covering, ceramic tile floor finish. Installation of kitchen fixtures and fittings, plumbing, drainage, sanitary fittings and electrics. The construction period is **Four (4) months**.

FLUCTUATIONS IN THE INPUT COST NOT APPLICABLE.

Registration with the National Contracts Commission (NCC) in the category **“Building Construction”**, **Grade 2 or higher is required.**

Bids **shall** be accompanied by a Bid Security in the amount of **Two Hundred and Ninety Thousand Dollars (\$290,000.00).**

Bidding will be conducted in accordance with tender procedures and guidelines specified in the: (i) Policies for the Procurement of Goods and Works financed by the Inter-American Development Bank – GN-2349-6; (ii) Government of Jamaica Handbook of Public Sector Procurement Procedures (Revised October 2010), Volume 2 of 4 Procedures for the Procurement of Goods, General Services & Works.

Interested eligible bidders may obtain further information from and inspect the bidding documents at the Jamaica Social Investment Fund at the address below from 9:00 a.m. to 4:00 p.m. Bid collection period **Monday, April 11, 2011 to Wednesday, April 27, 2011**. A complete set of bidding documents in English may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non-refundable fee of **Two Thousand Five Hundred Jamaican Dollars (JMD2,500.00)** for printed copy or **Five Hundred Jamaican Dollars (JMD500.00)** for Compact Disc (CD) in cash or certified cheque made payable to the Jamaica Social Investment Fund. **All bids must be submitted in printed copy. Original and Copy of the bid must be submitted in accordance with Instruction to Bidders.**

All bidders must be tax compliant at bid opening. **The original TCC must be presented at the bid opening or within two (2) days of the bid opening.**

Bids must be delivered to the address below by **12:00 noon on Thursday, April 28, 2011 at 12:00 noon**. Late bids will be rejected. Bids will be opened in the presence of bidders' representatives who choose to attend at the address below at **12:05 p.m. on Thursday, April 28, 2011.**
