1. The Government of Jamaica has received a loan from the International Bank for Reconstruction and Development toward the cost of the *INNER CITY BASIC SERVICES FOR THE POOR PROJECT*, and it intends to apply part of the proceeds of this loan to payments under the following Contracts:

Passmore Town Road Works - Package 1 – Kingston (#071602)

2. The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for **Passmore Town Road Works - Package 1 - Kingston**. The work involves the rehabilitation of **392m** of roadway, remedial works to drains and sidewalks associated with streets to be repaired. The delivery/construction period is **Four (4) months**.

All Bidders must be registered with the National Contracts Commission (NCC) at the time of bid opening in the category “**General Road Works**” in **Grade 3 or higher grades**. (See www.ocg.gov.jm).

Bids shall be accompanied by a Bid Security in the amount of **One Hundred and Thirty Seven Thousand Dollars (\$137,000.00)**.
