The Government of Jamaica has received a loan from the International Bank for Reconstruction and Development toward the cost of the *INNER CITY BASIC SERVICES FOR THE POOR PROJECT*, and it intends to apply part of the proceeds of this loan to payments under the following Contract for the *WASTE COLLECTION EQUIPMENT-PROCUREMENT OF SKIPS -MULTI-PARISH (#71691)*
2. The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for *WASTE COLLECTION EQUIPMENT-PROCUREMENT OF SKIPS - MULTI-PARISH*. The scope of works involves the fabrication/construction and transportation of the 47 garbage receptacles (skips) to the twelve ICBSP Communities. The fabrication/delivery period is **six (6) months**.

All Bidders must be registered with the National Contracts Commission (NCC) at the time of bid opening in the category “**Steel Fabrication**” in **Grade 3 or higher grades**. (See www.ocg.gov.jm).

Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank’s *Guidelines: Procurement under IBRD Loans and IDA Credits*, and is open to all bidders from Eligible Source Countries as defined in the guidelines and in accordance with tender procedures and guidelines specified in the Handbook of Public Sector Procurement Procedures (November 2008), National Contracts Commission, Sub-Section No. S-2040.

Interested eligible bidders may obtain further information from and inspect the bidding documents at the Jamaica Social Investment Fund at the address below from **8:30 a.m. to 4:45 p.m.** Bid collection period **Wednesday, November 4, 2009 to Thursday, December 3, 2009**. A complete set of bidding documents in English may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non-refundable fee of **Two Thousand Five Hundred Jamaican Dollars (JMD2,500.00)** for printed copy or **Five Hundred Jamaican Dollars (JMD500.00)** for Compact Disc (CD) in cash or certified cheque made payable to the Jamaica Social Investment Fund. **All bids must be submitted in printed copy. Original and Copy of the bid must be submitted in accordance with Instruction to Bidders.**

All bidders must be tax compliant at bid opening. **The original Tax Compliance Certificate (TCC) must be presented at the bid opening or within two (2) days of the bid opening.**

Bids must be delivered to the address below at or before **Friday, December 4, 2009, at 12:00 noon**. Electronic bidding *shall not* be permitted. Late bids will be rejected. Bids will be opened

physically on **Friday, December 4, 2009** in the presence of the bidders' representatives who choose to attend in person at the address below at **12:05 p.m.**
