JSIF's Community Link Revised

The JSIF Community Link has been revised as a monthly e-newsletter. It will continue to provide timely information about key developments and activities occurring in the Fund. This month's focus is the Rural Economic Development Initiative (REDI) project.



The Rural Economic Development Initiative (REDI) is a project geared towards executing smallagriculture scale and tourism community based projects in rural communities. Its main objective is to improve the earning potential of groups engaged in the business of agriculture and tourism.

To achieve this goal, small grants of up to US\$50,000.00 are available to implement projects of a business nature; while larger grants of up to US\$200,000.00 can be accessed for community projects in agriculture and tourism.

REDI is financed by a loan of US\$15m from the World Bank is slated for completion in 2016.

Community-based Tourism Policy coming!



The agreement for developing the Community-based Tourism Policy was signed at the Ministry of Tourism!

A new Community-based Tourism Policy aimed at creating a framework to enhance the policy and institutional capacity of community-based tourism will soon be a reality. The Government of Jamaica through the Ministry of Tourism signed the agreement with the Jamaica Social Investment Fund (JSIF) in early January to officially start the process.

Through the policy, local people will be empowered to utilize their rich talents and resources to transform their communities and enhance their livelihoods. It is envisioned that as a result of the implementation of this policy, Jamaica's natural and cultural heritage will be better promoted and protected thereby increasing the island's appeal to the discerning traveler.

More specifically, the Community-based Tourism Policy and Strategy is expected to support and encourage the development of community-based tourism enterprises (CBTEs) in the small and informal sectors; address the disadvantaged position of communities in the tourism marketplace; and involve local people in the planning of tourism activities.

As it relates to the policy itself, is expected that through its implementation, communities will have the capacity to play a greater role in the development of Jamaica's tourism industry

by taking ownership of the industry and providing high quality visitor experiences, in fulfillment of the Strategic Objectives of the Master Plan for Sustainable Tourism. Further, the institutional and legal capacity of the Government of Jamaica will be strengthened and appropriate modes of engagement for CBTEs detailed.

As a result, it is envisioned that the development of the Community-based Tourism policy will bring improved cooperation and collaboration across responsible ministries, departments and agencies (MDAs) of government, where each understands clearly their roles, in support of CBT.

developina the Community-based Tourism policy, broad based stakeholder input through national consultations will take place islandwide after which Parliamentary approval will be sought to convert the policy into law. The development of the Community-based Tourism policy is being funded under the JSIF implemented and World Bank financed REDI project to the tune of \$8.568-million.

Farmers Get Training!

Farmers' groups in the parishes of Manchester and St. Elizabeth are being provided with business training and capacity building to strengthen their ability to manage projects and improve the business aspect of their activities. This necessary training is being provided under the REDI project in conjunction with the Jamaica Exporters' Association's parent body the Export Centre/ **Business Information** Point.

More specifically, the project's objective is to increase the income earning potential of

Information Corner

What is practical completion?

The Contractor requests 'practical completion' when all the construction/rehabilitation work has been completed. The Certificate of Completion of Works is issued by the Supervising Consultant after the walk-through of the site and the determination by the Supervising Consultant that the work is complete. The Defects Liability Period specified in the Contractor's contract begins after the Certificate of Completion of Works is issued.



Did you know that honey is 80% sugars and 20% water? To make one pound of honey, the bees in the colony must visit 2 million flowers,

fly over 55,000 miles and will be the lifetime work of approximately 300 bees. A single honeybee will only produce approximately 1/12 teaspoon of honey in its lifetime.
