1. The European Union (EU) through the 10th European Development Fund (EDF) and the Government of Jamaica (GoJ) jointly funds the Poverty Reduction Programme (PRP). The Jamaica Social Investment fund (JSIF) is the implementing agency for the PRP. The purpose of the programme is the improvement in socio-economic conditions and quality of life in communities with emphasis on the promotion of community safety and the reduction of criminal behaviour in volatile and vulnerable communities. Specifically, the PRP will improve the living conditions of the poor by providing access to quality basic infrastructure and services.

The Government of Jamaica intends to apply part of the proceeds of this grant to cover payments under the following contracts:

HOLY FAMILY INFANT SCHOOL REHABILITATION - KINGSTON (#073340).

The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for the proposed **Holy Family Infant School Rehabilitation** – **Kingston**. The scope of works involves the installation of a suspended ceiling, demolition of breeder blocks, concrete block works, installation of windows and doors, termite treatment, electrical rehabilitation, renovation of bathroom block, construction of play area, general painting, provision of outside learning area/green space and the construction of concrete wheel chair ramps. *Construction period is three* (3) *months*.

The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for the proposed **Central Branch All Age School Sanitation** – **St. Andrew**. The scope of works involves the rehabilitation of existing bathroom block, construction of garbage collection enclosure, installation of chain link fencing, construction of tank base and supply and connection of water tanks, construction of landscaped walkway and the demolition of a partially demolished building and general clearing of a section of the site. *Construction period is three* (3) *months*.

The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for the proposed **Osbourne Store Primary School Rehabilitation** – **Clarendon**. The scope of works include but

is not limited to repairs to Block C roof covering, ceiling and floor to be fixed, rehabilitation of electrical works to include installation of adequate4 lightening arresters, partitioning of classrooms and internal and external painting. Blocks A, B and C and bathroom units to be retrofitted with wheel chair ramps and one stall in each bathroom to be retrofitted for wheelchair accessibility. *Construction period is three (3) months.*

The scope of works involves removal and re-construction of the existing timber roofs, demolition and re-construction of the kitchen to include eating area, construction of wheel chair ramps, rehabilitation of the bathroom block, electrical rewiring, partitioning of the classrooms and painting of the facility. **Construction period is three (3) months.**

The scope of works includes but is not limited to the demolition and construction of a new 4-classroom block with an administrative area, a kitchen and 2 student bathrooms. Works also includes installation of a 70m chain-link perimeter fence. **Construction period is three (3) months.**

All national Bidders must be tax compliant at bid opening and a valid **Tax Compliance Certificate** (**TCC**) and proof of registration with the **National Contracts Commission** (**NCC**) in the category "**Building Construction**" in <u>Grade 2 or higher</u> must be submitted with their bid at the time of bid opening.
