The Jamaica Social Investment Fund (JSIF) was established in 1996 as a component of the Government of Jamaica's strategy to reduce poverty. The Fund promotes, appraises, finances and supervises social and economic infrastructure projects, including schools, roads, agro-processing, water, sanitation, health centres, community centres, homes for children and the elderly, as well as, vocational skills training, counselling, parenting, life education and organizational strengthening.

The Government of Jamaica has received a loan from the World Bank towards the cost of the **INTEGRATED COMMUNITY DEVELOPMENT PROJECT (ICDP)**, and it intends to apply part of the proceeds of this loan to cover payments under the **Canaan Heights Integrated Infrastructure Project – Clarendon (#73417)**.

Bid No. 7760

The Jamaica Social Investment Fund intends to prequalify Civil Works Contractors registered with the National Contracts Commission (NCC) in the category **Grade 1 in “Civil Engineering” and/or “General Road Works”** for the **Canaan Heights Integrated Infrastructure Project – Clarendon**. The proposed scope of works entails but is not limited to the rehabilitation and construction of approximately 1,100m of roadway, the construction of approximately 735m of various size concrete u-drains, the installation of approximately 1,450m of 200mm diameter pvc sewer pipelines, 1,149m of 100mm diameter pvc sewer pipelines, the construction of a lift station inclusive of pumps and the installation of service laterals and fire hydrants.

It is expected that invitations for bid will be made in November 2017.

Prequalification will be conducted through prequalification procedures specified in the World Bank's *Guidelines: Procurement Under IBRD Loans and IDA Credits*, January 2011 and is opened to all bidders from Eligible Source Countries as defined in the guidelines and the Government of Jamaica Handbook of Public Sector Procurement Procedures (Revised March 2014), Volume 2 of 4 Procedures for the Procurement of General Services, Goods and Works.

Interested eligible bidders may obtain further information from, and inspect the prequalification document at the Jamaica Social Investment Fund at the address below from **Wednesday, September 6, 2017 at 8:30am to Thursday, October 5, 2017 at 1:00 p.m.** A complete set of prequalification documents in English may be purchased by interested bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of **Two Thousand Five Hundred Dollars (J\$2,500.00)** for printed copy and **Five Hundred Dollars (J\$500.00)** for Compact Disc in cash or certified cheque made payable to the Jamaica Social Investment Fund.
