The Jamaica Social Investment Fund (JSIF) was established in 1996 as a component of the Government of Jamaica’s strategy to reduce poverty. The Fund promotes, appraises, finances and supervises social and economic infrastructure projects, including schools, roads, agro-processing, water, sanitation, health centres, community centres, homes for children and the elderly, as well as, vocational skills training, counselling, parenting, life education and organizational strengthening.

The Government of Jamaica has received a loan from the World Bank towards the cost of the **INTEGRATED COMMUNITY DEVELOPMENT PROJECT (ICDP)**, and it intends to apply part of the proceeds of this loan to cover payments under the **Rose Town Integrated Infrastructure Project – St. Andrew (#73415)**.

The Jamaica Social Investment Fund intends to prequalify Civil Works Contractors registered with the National Contracts Commission (NCC) in the category **“Grade 1 in “Pipe Laying” and/or “Civil Engineering” and/or “General Road Works”** for the **Rose Town Integrated Infrastructure Project – St. Andrew**. The scope of works include but is not limited to the installation of approximately 7850m of 100mm diameter PVC water supply pipelines, 4480m of 100mm diameter and 2770m of 200mm diameter PVC Sanitary sewer pipes, installation of service laterals, fire hydrants and reinstatement of roadway pavement.

It is expected that invitations for bid will be made in January 2018.

Prequalification will be conducted through prequalification procedures specified in the World Bank’s *Guidelines: Procurement Under IBRD Loans and IDA Credits*, January 2011 and is opened to all bidders from Eligible Source Countries as defined in the guidelines and the Government of Jamaica Handbook of Public Sector Procurement Procedures (Revised March 2014), Volume 2 of 4 Procedures for the Procurement of Goods, General Services & Work.

Interested eligible bidders may obtain further information from, and inspect the prequalification document at the Jamaica Social Investment Fund at the address below from **Wednesday, November 15, 2017 to Monday, December 18, 2017 between the hours of 8:30 a.m. and 4:45 p.m.** A complete set of prequalification documents in English may be purchased by interested bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of **Two Thousand Five Hundred Dollars (J\$2,500.00)** for printed copy and **Five Hundred Dollars (J\$500.00)** for Compact Disc in cash or certified cheque made payable to the Jamaica Social Investment Fund.

Applications for prequalification should be submitted in sealed envelopes, delivered to the address below by Tuesday, December 19, 2017 at 2:00 p.m. and be clearly marked “Application to Prequalify for Rose Town Integrated Infrastructure Project – St. Andrew (#73415) Bid No. 7862.”

Bids will be opened in the presence of Bidders’ Representatives who choose to attend at the address indicated below on Tuesday December 19, 2017 at 2:10 p.m.
