Jamaica Social Investment Fund now invites sealed bids from eligible bidders for the ICDP - Procurement for the Supply of Two (2) Tyre Shredders for the National Solid Waste Management Authority. The scope of works involves the supply and delivery on site of:

- 1. Two (2) tyre shredders in accordance with the Technical Specification in the bidding document.
- 2. Provision of Training for NWSMA Staff who will use the machines
- 3. Provision of maintenance services for 24 months.
- 4. The delivery/installation period is Four (4) months.

All Bidders must be registered with the National Contracts Commission (NCC) at the time of bid opening in the category "Industrial, Construction Equipment and Machinery" (see <a href="www.ocg.gov.jm">www.ocg.gov.jm</a>). Failure to include National Contracts Commission Certificate/Letter with bid will result in disqualification.

- 2. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits*, and is open to all bidders from Eligible Source Countries as defined in the guidelines and the Government of Jamaica Handbook of Public Sector Procurement Procedures (Revised March 17, 2014), Volume 2 of 4 Procedures for the Procurement of Goods, General Services & Works.
