The Jamaica Social Investment Fund (JSIF) was established in 1996 as a component of the Government of Jamaica's strategy to reduce poverty. The Fund promotes, appraises, finances and supervises social and economic infrastructure projects, including schools, roads, agro-processing, water, sanitation, health centres, community centres, homes for children and the elderly, as well as, vocational skills training, counselling, parenting, life education and organizational strengthening.

The Government of Jamaica has received a loan from the World Bank towards the cost of the INTEGRATED COMMUNITY DEVELOPMENT PROJECT (ICDP), and it intends to apply part of the proceeds of this loan to cover payments under the following contracts for the Enhancement to Water Supply Access which comprise of the following Lots:

The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for the **Design & Build for the Enhancement to Water Supply Access for Hannah Town, Kingston.** The scope of works include the design and build of pump and piping works for Hannah Town. The pump should facilitate the pumping of water to the third and fourth floor of high-rise building. Design should also include storage tank, water control centre and other appurtenances and fixtures. **The Delivery time** (design and construction) is Six (6) months including Three (3) month Defect Liability Period.

All Bidders must submit in their bids a valid **Tax Compliance Certificate** (TCC) **or Tax Compliant Letter** (TCL) and proof of registration with the **National Contracts Commission** (NCC) in the categories **Grade 4 or higher in "Civil Engineering" or Grade 3 or higher in "Mechanical Works"** and must be included in the bid submission (see www.ncc.gov.jm).

Lot 2 (Bid No. 8483) – Design & Build for the Enhancement to Water Supply Access for Wilton Gardens, Kingston (#073613)

The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for the **Design & Build for the Enhancement to Water Supply Access for Wilton Gardens, Kingston.** The scope of works include the design and build of pump and piping works for Wilton Gardens. The pump should facilitate the pumping of water to the third and fourth floor of high-rise building. Design should also include storage tank, water control centre and other appurtenances and fixtures. **The Delivery time** (design and construction) is Seven (7) months including Three (3) month Defect Liability Period.

All Bidders must submit in their bids a valid **Tax Compliance Certificate** (TCC) **or Tax Compliant Letter** (TCL) and proof of registration with the **National Contracts Commission** (NCC) in the categories **Grade 2 or higher in "Civil Engineering" or Grade 2 or higher in "Mechanical Works"** and must be included in the bid submission (see www.ncc.gov.jm).

Bids MUST be accompanied by Bid Security in the amount of Fifty Thousand Jamaican Dollars (J\$50,000.00).

Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank's Guidelines Procurement of Goods, Works, and Non-Consulting Services: Procurement under IBRD Loans and IDA Credits (July 2014), and is opened to all bidders from Eligible Source Countries as defined in the guidelines.

Payment must be made in cash or by certified cheque made payable to the Jamaica Social Investment Fund. All bids must be submitted in printed copy. Original and Copy of the bid must be submitted in accordance with Instruction to Bidders.
- 4. Bids must be delivered to the address below and deposited in the bid box located in the lobby, before 12:00 noon on Wednesday, September 18, 2019. Late bids will be rejected.

Bids will be opened in the presence of bidders' representatives who choose to attend at the address below at 12:10 p.m. on Wednesday, September 18, 2019.
