The Jamaica Social Investment Fund (JSIF) was established in 1996 as a component of the Government of Jamaica’s strategy to reduce poverty. The Fund promotes, appraises, finances and supervises social and economic infrastructure projects, including schools, roads, agro-processing, water, sanitation, health centres, community centres, homes for children and the elderly, as well as, vocational skills training, counselling, parenting, life education and organizational strengthening.

The Government of Jamaica has received a loan from the World Bank towards the cost of the **INTEGRATED COMMUNITY DEVELOPMENT PROJECT (ICDP)**, and it intends to apply part of the proceeds of this loan to cover payments under the following contracts for **ICDP School Rehabilitation Package 2** which comprise of the following Lots:

BIDDERS MAY BID ON ANY OR ALL LOTS

Lot 1 (Bid No. 8167) – St. Andrew Primary School Rehabilitation – St. Andrew (#073620)

The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for the **St. Andrew Primary School Rehabilitation**. The scope of works include minor construction and basic rehabilitation to the school’s infrastructure. The works include, but is not limited to, roof repairs, construction of nominal size multiple-purpose courts, parking areas and paved surfaces, rehabilitation and/or installation of rainwater harvesting system, installation of new windows, doors, plumbing fixtures, lighting fixtures, electrical works, internal and external painting, installation of perimeter fencing and renovation of security post. **The construction period is three (3) months.**

All Bidders must be tax compliant at bid opening. Valid **Tax Compliance Certificate (TCC) or Tax Compliant Letter (TCL)** and proof of registration with the **National Contracts Commission (NCC)** at **Grade 3 or higher** in the category of **“Building Construction” OR Grade 3 or higher** in the category of **“Civil Engineering”** must be included in the bid submission (see www.ncc.gov.jm).

Lot 2 (Bid No. 8168) – Rousseau Primary School Rehabilitation – St. Andrew (#073619)

The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for the **Rousseau Primary School Rehabilitation**. The scope of works include minor construction and basic rehabilitation to the school’s infrastructure. The works include, but is not limited to, roof repairs, construction of nominal size multiple-purpose courts, parking areas and paved surfaces, rehabilitation and/or installation of rainwater harvesting system, installation of new windows, doors, plumbing fixtures, lighting fixtures, electrical works, internal and external painting, installation of perimeter fencing and renovation of security post. **The construction period is three (3) months.**

All Bidders must be tax compliant at bid opening. Valid **Tax Compliance Certificate (TCC) or Tax Compliant Letter (TCL)** and proof of registration with the **National Contracts Commission (NCC)** at **Grade 4 or higher** in the category of **“Building Construction” OR Grade 4 or higher** in the category of **“Civil Engineering”** must be included in the bid submission (see www.ncc.gov.jm).

Lot 3 (Bid No. 8169) – Maxfield Park Primary School Rehabilitation – St. Andrew (#073452)

The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for the **Maxfield Park Primary School Rehabilitation**. The scope of works include minor construction and basic rehabilitation to the school’s infrastructure. The works include, but is not limited to, roof repairs, construction of nominal size multiple-purpose courts, parking areas and paved surfaces, rehabilitation and/or

installation of rainwater harvesting system, installation of new windows, doors, plumbing fixtures, lighting fixtures, electrical works, internal and external painting, installation of perimeter fencing and renovation of security post. **The construction period is three (3) months.**

All Bidders must be tax compliant at bid opening. Valid **Tax Compliance Certificate (TCC) or Tax Compliant Letter (TCL)** and proof of registration with the **National Contracts Commission (NCC)** at **Grade 3 or higher** in the category of “**Building Construction**” **OR Grade 3 or higher** in the category of “**Civil Engineering**” must be included in the bid submission (see www.ncc.gov.jm).

Bids MUST be accompanied by Bid Security in the amount of Fifty Thousand Jamaican Dollars (J\$50,000.00).

Lot 4 (Bid No. 8170) – Greenwich Primary School Rehabilitation – St. Andrew (#073453)

The Jamaica Social Investment Fund now invites sealed bids from eligible and qualified bidders for the **Greenwich Primary School Rehabilitation**. The scope of works include minor construction and basic rehabilitation to the school’s infrastructure. The works include, but is not limited to, roof repairs, construction of nominal size multiple-purpose courts, parking areas and paved surfaces, rehabilitation and/or installation of rainwater harvesting system, installation of new windows, doors, plumbing fixtures, lighting fixtures, electrical works, internal and external painting, installation of perimeter fencing and renovation of security post. **The construction period is three (3) months.**

All Bidders must be tax compliant at bid opening. Valid **Tax Compliance Certificate (TCC) or Tax Compliant Letter (TCL)** and proof of registration with the **National Contracts Commission (NCC)** at **Grade 4 or higher** in the category of “**Building Construction**” **OR Grade 4 or higher** in the category of “**Civil Engineering**” must be included in the bid submission (see www.ncc.gov.jm).

Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank’s Guidelines Procurement of Goods, Works, and Non-Consulting Services: Procurement under IBRD Loans and IDA Credits (July 2014), and is opened to all bidders from Eligible Source Countries as defined in the guidelines.

Payment must be made in cash or by certified cheque made payable to the Jamaica Social Investment Fund. **All bids must be submitted in printed copy. Original and Copy of the bid must be submitted in accordance with Instruction to Bidders.**

4. Bids must be delivered to the address below and deposited in the bid box located in the lobby, before **12:00 noon on Wednesday, February 20, 2019. Late bids will be rejected.** Bids will be opened in the presence of bidders’ representatives who choose to attend at the address below at **12:10 p.m. on Wednesday, February 20, 2019.**
