## Chairman's Statement

Poverty is a complex problem that requires a broad-based and multi-pronged approach to address the root causes. The Government of Jamaica, in its effort to improve the quality of life of the Jamaican people and ensuring social stability, has recognized the need to address this social malady and has therefore placed the eradication of poverty as a top priority on the national agenda.

The establishment of the National Poverty Eradication Programme (NPEP) in 1995 is an outgrowth of the Government's commitment to making Jamaica safe, secure and prosperous. The NPEP aims to provide the proper physical and social infrastructure which is needed to promote sustainable development. The National Poverty Eradication Programme built on the principles of partnership, community participation and sustainability seeks to empower people and communities to live quality lives.

#### The Jamaica Social Investment Fund

The Jamaica Social Investment Fund was established in 1996 as a poverty alleviation and eradication project aimed at improving social capacity and empowering underserved communities throughout Jamaica. The Fund firmly believes in fostering social capital through a participatory approach that utilizes a demand-driven process. Therefore in the JSIF project process, communities are empowered to take the lead role in deciding on which project is a priority. Each community then works together towards a Over the years we have common goal. found that when this strategy is employed, communities become empowered to take ownership of their projects. They are also encouraged to participate fully in the implementation process.

Originally, the Jamaica Social Investment Fund was created with a projected lifespan of 4 years. We have surpassed our original targets and are now in our 9th year with an additional lifeline given until 2007. To date JSIF has approved seven hundred and seventy seven (777) projects, completed five hundred and twenty six (526) projects and contracted six hundred and ninety one 691 projects. JSIF is currently focused on implimenting social infrastructure projects, with particular emphasis placed on school ad water projects. The passing of Hurricane Ivan strongly influenced the number of projects that were approved in the year with a little over one hundred (100) of the projects being repairs to damaged schools.

The JSIF is having a positive impact in many underserved communities across Jamaica. One example of this positive trend is the contribution that the JSIF along with other social agencies, made towards the parish of St. Mary in reducing poverty since 2001. The experience reinforces the fact that the programs are successfully fulfilling the goal of helping the underserved. However, it also means that the poorest areas have been redefined and so our job continues.

#### **Partnerships**

In this past year JSIF has seen a deepening of partnerships with Ministries, Government Agencies, the Private Sector and Non-Government Organizations. There have been a number of events that have underlined the importance of collaboration in achieving the overall goal of improving the social infrastructure for Jamaica's most underserved.

The GoJ, with funds provided by the EU, cofinanced along with the Ministry of Water & Housing a two-day Water Sanitation and Hygiene (WASH) conference, under the theme, 'Community Managed Water and Sanitation: Empowerment for Sustainable Rural Development. The conference was in keeping with the United Nations Millennium Development Goals that were adopted at the 2000 Millennium Summit of the United Nations Goal Number 7, which speaks to halving the number of people without access to clean and safe water by 2015.

The JSIF is very cognizant of the need to ensure that all sectors are involved for a tangible and sustainable impact to be had on the goal of poverty alleviation and eradication. Although Non-Governmental (NGO), Organizations Ministries and Executive Agencies have been playing an integral role, the contribution made by the private sector and individuals is also an essential ingredient. One example was the successful partnership between the JSIF and the Digicel Foundation in 2004 for the construction and equipping of the Lakes Pen Basic School. The project was completed on time and within budget in a record six months and at a total cost of J\$9.8 million. The fifty students and three members of staff at the school are now benefiting from a new, fully equipped three-classroom block, kitchen, sanitary facilities as well as playground equipment. We are continuing the very successful partnership with Digicel through the implementation of the Mount Pelier Basic School construction project located in St. Elizabeth



The flexibility of the Fund is a source of its strength. This was demonstrated after the passage of Hurricane Ivan in September of 2004 when over 300 schools were damaged. The Fund gave full support to the Office of National Reconstruction (ONR), the agency that spearheaded the recovery effort. In its bid to get the education sector



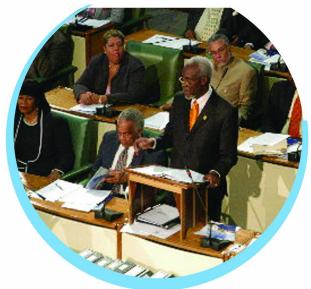

up and running, the JSIF undertook the task of repairing approximately 100 schools island wide at an approved cost of approximately US\$3 million that was allocated by the World Bank for Hurricane Ivan reconstruction. We have completed approximately 75% of the reconstruction in time for the opening of school in September.

#### **Project Funding**

The Jamaica Social Investment Fund is responsible for the implementation of a number of social development projects. The Inner City Basic Services for the Poor (ICBSP) project is one such example. This project is aimed at improving access, use and quality of socio-economic infrastructure, including rehabilitation and construction on sanitation, drainage and water supply facilities. solid waste collection, lighting and sewage, rehabilitation of public space and recreation areas, pedestrian and nonmotorized transport improvement and violence and crime reduction. These activities will embrace strong community participation to build the social infrastructure needed to improve the social conditions in the targeted communities. It is anticipated that the project will come on stream by the fourth quarter of the financial year. The main project components include Water and Sanitation, Crime and Violence Prevention, and Improved Access to Basic and Economic Infrastructure.

Prime Minister P.J. Patterson in his contribution to the 2005-2006 Budget Debate confirmed that the JSIF would receive funding of US\$5 million from the Organization of Petroleum Exporting Countries (OPEC) with additional US\$25 million from the WB to fund the Inner City Basic Services for the Poor.

The OPEC funding is being used to expand the new community based contracting (CBC) modality, which is a component of the World Bank financed National Community Development Project. JSIF continues to implement projects with grant funding provided by CIDA through the Basic Needs Trust Fund and the EU. The EU has used the CBC modality exclusively in the implementation of the Poverty Reduction Programme projects.

Additional grant funding also has been secured in the amount of US\$650,000 from the Japanese PHRD Fund to help finance the project preparation activities necessary. The grant will be used to establish a planning framework that will enable local communities and other key stakeholders to fully participate in the final design of the project. The JSIF will act as the implementing agency for the project, which will address inner city basic services priorities.

The JSIF is indeed a dynamic organization that continues to respond to the changing needs of its clientele. With efficiency,

### Managing Director's Report

#### Overview

Throughout its nine years, the Jamaica Social Investment Fund has honoured its mandate of providing basic social and economic infrastructure for Jamaica's most underserved communities.

As at March 2005 the Board of Directors approved 777 sub-projects for islandwide implementation, 526 of which have been completed. This reflects a total investment of J\$ 3.2 billion. Funding for these projects has been provided through a combination of loans and grants from the Government of Jamaica, the World Bank, the European Union, the Caribbean Development Bank, the Canadian International Development Agency, the Organization of Petroleum Exporting Countries, the Inter-American Development Bank, the Government of the Netherlands, the Department For International Development (UK), the Government of Japan and the beneficiary communities.

When compared with the previous year's performance this year<sup>1</sup> saw an improvement in the number of projects that were approved by our Board of Directors, the number of projects completed and the total funds disbursed. The Fund's total disbursement on sub-project expenditures is approximately J\$ 553M. In 2004/05 our Board of Directors approved one hundred and fifty eight (158) projects at a cost of approximately J\$ 393M. During the year we completed fifty-eight (58) projects at an approximate cost of J\$ 196M.

#### Responding to Underserved Communities

This year was an extremely challenging one for the nation with the entire island being affected by Hurricane Ivan. In the face of these very demanding circumstances the Jamaica Social Investment Fund rose to the challenge and committed approximately US\$ 3 million, facilitated by the World Bank's NCDP funds, to carry out repairs to over 100 schools damaged by Hurricane Ivan. These repairs were carried out in partnership with the Office of National Reconstruction.

A key component of our strategy to assist the underserved communities and for the subsequent sustainability of projects is the participation of the beneficiary communities. All projects implemented by JSIF require that at least 5% of the total project cost be provided by the community and in this regard, JSIF's programmes are unique. To date, communities have contributed in excess of US\$ 3 million towards their projects.

In order to further maximise the socioeconomic impact of our projects on communities, during the year we embarked approach project on a new to implementation termed Community Driven Development (CDD). One of the of this methodology is components Community Based Contracting (CBC). Under CBC, communities are responsible for the management and implementation of their projects, with the JSIF playing a facilitative role. Funds are channelled directly to the community and the community is fully responsible for the procurement of goods and services, with the JSIF facilitating the training and capacity-building to enable the community to be better able to carry out these activities.

During the year, JSIF invested approximately J\$ 2.5 million to train communities. Up to March 2005, JSIF approved forty-two (42) projects under the CBC component at a value of approximately J\$ 293M.

The approach has encouraged not only greater community participation but also greater collaboration among government agencies and JSIF. #### **Financing Community Advancement**

Throughout 2004/05 sub-project costs were funded through a US\$ 15 million loan from the World Bank to finance the National Community Development Project (NCDP), a Euro\$ 6 million grant from the European Union to fund the Poverty Reduction Programme (PRP), a US\$ 2.86M grant from the CIDA/CDB Basic Needs Trust Fund (BNTF), the Government of Jamaica's counterpart funding and contributions from benefiting communities.

For the financial year 2004/05<sup>2</sup> JSIF received approximately US\$ 27.1 million to

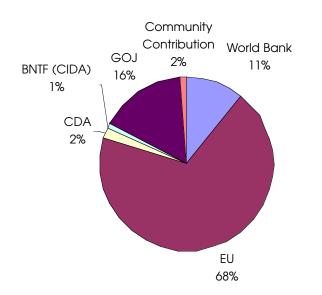
finance sub-project implementation and day-to-day operations, and is broken down as follows:

• US\$ 3.0 million was received from the World Bank

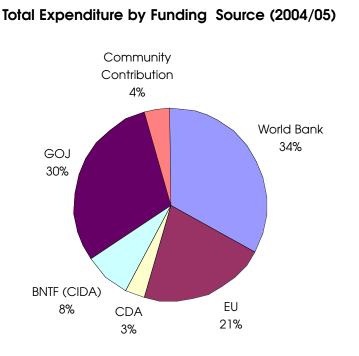
- US\$ 18.6 million was received from the EU

date, JSIF has disbursed To а total US\$ 9.15M of sub-project on and administrative expenditures. Total expenditure was financed mainly through funding from the World Bank, European Union and the Government of Jamaica.



#### Looking Towards The Future

In spite of our hard work and many successes much remains to be done to alleviate poverty in Jamaica. We continue to play an important role in the government's poverty alleviation policies and will continue our mission of assisting underserved communities to improve their social and economic infrastructure.

The JSIF, through its transparent procedures and enviable track record, continues to attract funding. Through the Ministry of Finance, we have recently entered into a US\$5M with the loan agreement Organization of Petroleum Exporting Countries (OPEC) and received a US\$650,000 grant from the Government of Japan for the preparation and design of a new project – The Inner City Basic Services for the Poor Project (ICBSP).

This project is designed to improve access to basic and socio-economic infrastructure for residents in targeted communities in Kingston and St. Andrew, St. Catherine, Clarendon and St. James. The government has received commitments from the World Bank to provide a loan of US\$25 million towards its implementation. The project proposes to improve access to water and sanitation, waste collection and lighting; rehabilitate public spaces and recreation areas implement crime and violence initiatives. The targeted communities are Whitfield Town, Dunkirk, Jones Town and Federal Gardens in Kingston and St. Andrew; Tawes Pen, Africa, Detroit, Big Lane, Little Lane, Shelter Rock, Andrews Lane, Lauriston and Bog Walk in St Catherine; Bucknor/Rectory Lands in Clarendon and Flankers in St James.

A new thrust of the JSIF this year was the forging of effective partnerships with the private sector to further advance the mission of poverty alleviation. As such, JSIF had successful partnerships with entities including the Digicel Foundation, Scotiabank, Courts and service clubs such as Rotary International. We are grateful for the support of the private sector thus far and we welcome other similar collaborations, which is a reflection of JSIF's willingness to partner using both state and private sector funding to address the most pressing socio-economic needs in our communities.

The JSIF is always open to new and innovative methods of community development and is presently exploring the "Programa Puente" based on the Chilean model. This is a model for poverty alleviation currently being used in Chile, which focuses on poverty alleviation at the family level as existina focus on opposed to the communities. It is an integral intervention programme, designed to give psychosocial support to families that live in conditions of

The extreme poverty. methodology implemented by the programme promotes the development of initiatives for the improvement of the participating families' standard of living and eventual integration into the network of social services that are at their disposal. A key element of the programme is that participating families agree to achieve certain basic/minimum conditions aimed at improving their quality of life in the areas of identification, health, education, income, family dynamics and employment. We hope to apply aspects of this approach to our efforts of poverty alleviation in Jamaica. The experiences of this programme should provide a fresh approach to assisting the underserved.

We remain committed to our mandate and are eagerly looking forward to the next year as we continue our efforts to ensure that more Jamaicans have access to basic social infrastructure.

#### Highlights of Some Ongoing and Completed Projects (2004/2005)

#### Water Supply Projects - EU PRP

• An estimated J\$80 million has been allocated by a grant from the GOJ/EU Poverty Reduction Programme for the implementation of 29 projects including water supply systems, sanitation, health, roads and schools. The community contribution aspect is valued at approximately J\$ 22 million.

• Six (6) community water supply infrastructure projects are being implemented in the communities of Hampstead, Bellevue, Bybrook, Mountain Pass, Pedro River Supply and Rowlandsfield.

• These were the first water projects that utilized the CBC methodology for project implementation.

• An estimated 7,500 citizens are expected to benefit from these projects.

#### Lime Hall Health Centre Completion – WB

• Prior to approaching the JSIF, the community had initiated fundraising efforts to begin construction of the health centre and provided voluntary labour to construct the building. Financing for the completion of the health centre was identified under the World Bank's NCDP loan. It is projected to cost approximately J\$9 million with the community contributing half of the funds.

• This community demonstrated commitment to the CBC approach

because even after they had applied to JSIF and were visited by representatives from the Fund they continued to raise money and work on the building.

• Beneficiaries will number approximately 10, 000 after the centre is completed.

#### Craighton All Age School Rehabilitation & Expansion - CDB

• The original school was comprised mainly of a wooden building that was constructed over 100 years ago. The project involved the partial demolition and reconstruction of the structure.

• Some 154 students and 6 staff members have benefited from the upgrading of the school, which is the only educational institution of its kind in the area and serves 4 major districts in St. Andrew.

• The cost of the project was approximately J\$14.6 million and was financed through the Caribbean Development Bank.

#### Homestead Place of Safety – BNTF (CIDA)

• This project involved the installation of a new roof and ceiling, rehabilitation of the bathroom and kitchen, expansion of the dining area and rehabilitation of drainage and electrical wiring.

• The boys who reside at the home are wards of the state who come from various parishes islandwide, some as far as Westmoreland, Clarendon and Manchester. The Homestead Place of Safety has been in existence for well over 51 years and caters to boys between the ages of 8 - 18 years old.

• The project benefited some 65 "at risk" boys and 23 staff members.

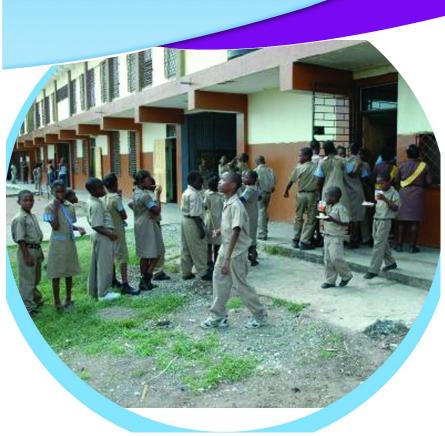
• The cost of the project was approximately \$13M and was funded though the Basic Needs Trust Fund.

#### Iris Gelley Primary School - WB

• The Iris Gelley Primary School was expanded and rehabilitated at an approximate cost of J\$15 M provided through the World Bank's NCDP Loan.

• The project included the construction of a new classroom and sanitation blocks. Chronic overcrowding was a problem at this school, which served children from the Jones Town and Trench Town communities. Construction of this new classroom block remedied this situation.

### JAMAICA SOCIAL INVESTMENT FUND FINANCING

Initial funding for the JSIF was obtained from the World Bank (IBRD / WB) in the form of a US\$20 million loan, this helped to leverage assistance from other sources as follows the Inter-American Development Bank (IDB) US\$10 million, the Government of the Netherlands US\$3 million, Organisation of Petroleum Exporting Countries (OPEC) US\$2 million, the Department and for International Development (DFID) £476,000 (US\$0.75M). In 2000, additional funding in loans and grants was secured from the Caribbean Development Bank (CDB) US\$14.32M, and the European Union ¤ 6 million respectively.

JSIF was chosen as the executing agency for the EU's Poverty Reduction Programme (PRP), which is funded by an EU ¤ 6 million grant because of the Fund's notable success in targeting and improving the conditions in some of the poorest communities. This Project has an increased emphasis on community contracting and beneficiary participation; which gives communities more control over the design and implementation of their projects.

The WB is also taking a community driven approach through its, National Community Development Project (NCDP), which is financed by a loan of US\$15M to the Government of Jamaica (GOJ). The NCDP is focused on development through increased involvement of the community at all stages of the project cycle. It was officially launched on February 17, 2003 and is to be implemented over a four (4) year period. In 2005 the GOJ obtained further funding to support the NCDP from the Organisation of Petroleum Exporting Countries, which has entered into a loan agreement for US \$5 million that will end in 2009.

Further funding was obtained in June 2003 with The Basic Needs Trust Fund grant of US\$2.86M, which is being provided jointly by the CDB and the Canadian International Development Agency (CIDA). This grant makes funding available for infrastructure construction, minor maintenance for education and health facilities, skills training and upgrading, institutional strengthening, public awareness and information, and project management and implementation. During 2005 the GOJ negotiated with the WB to provide financing for the preparation of the Inner City Basic Services for the Poor (ICBSP), a project intended to improve access to basic and socio-economic infrastructure for residents in targeted

communities in Kingston and St. Andrew, St. Catherine, Clarendon and St. James. A grant of US\$650,000 has been provided from the Japanese Policy and Human Resources Development (PHRD) fund, along with a project preparation loan of US\$650,000 from the WB toward these project preparation activities. It is anticipated that the ICBSP will commence implementation early in the next financial year with funding of approximately US\$25M from the WB.

### IDENTIFICATION

1

The company which was incorporated in Jamaica, is the vehicle used to carry out all the activities of the Jamaica Social Investment Fund (JSIF) project. The registered office of the company is 1C-1F Pawsey Road, Kingston.

The Jamaica Social Investment Fund (JSIF) is a temporary, autonomous Government of Jamaica (GOJ) sponsored project designed to address some of the most pressing socio-economic needs of the poorest. In order to achieve this, the JSIF mobilizes resources from the Government, donors and lending agencies.

The initial JSIF project was funded in its first six years, that is, up to March 31, 2003, by a series of grants and loans as follows:

(a) Initial project preparation costs were funded under the Grant Agreement No. TF 029209 between the GOJ and the Government of Japan.

Other financing arrangements made to fund the project activities were:

(b) Loan Agreement No. 4088 JM between the GOJ and International Bank for Reconstruction and Development (IBRD) dated October 2, 1996 to borrow US\$20 million.

Disbursement was completed in March 2002.

(c) Loan Contract No. 1005/OC-JA between the GOJ and the Inter-American Development Bank (IDB) dated July 25, 1997 to finance up to US\$10 million.

The final disbursement was made in August 2002.

(d) Grant Agreement No. TF024816 between the GOJ and the Government of Netherlands (GON), IBRD being the Administrator on behalf of the Netherlands Minister for Development Cooperation, dated March 26, 1997 for funds totalling US\$3 million (5,250,000 Netherlands Guilders (NLG)).

Disbursement was completed in August 2001.

(e) Memorandum of Understanding between the GOJ, JSIF and the European Union dated December 12, 1996 for funds totalling \$91 million (US\$2.6 million). This sum forms a part of the GOJ counterpart funding referred to in (f) below.

- (f) Implementation Letter from GOJ and JSIF to IBRD dated October 2, 1996 confirming the availability of the minimum counterpart funding of US\$10 million.
- (g) Loan Agreement No. 685P between the GOJ and the Organization for Petroleum Exporting Countries (OPEC) dated April 21, 1997 to borrow US\$2 million.

Disbursement was completed in February 2002.

(h) Arrangement between the GOJ and the Government of the United Kingdom of Great Britain and Northern Ireland dated May 16, 1997 to make available a technical cooperation grant through the Department for International Development (DFID), previously Overseas Development Administration (ODA) up to £476,000.

The grant expired in December 2001.

(i) Beneficiaries and sponsors of sub-projects were obligated to contribute a minimum of 5% of the estimated sub-project cost in the form of donated labour, local materials and project preparation and supervision services.

Continuing project activities is financed as follows:

(a) Loan Agreement No. 10/SFR-OR-JAM between the GOJ, JSIF and the Caribbean Development Bank (CDB) dated May 26, 2000 to finance up to US\$14.128 million.

Grant Agreement No. GA10/JAM between the JSIF and the Caribbean Development Bank dated May 26, 2000 for funds totalling US\$124,000.

- (b) Grant Agreement No. 6349/JM between the GOJ and the Commission of the European Communities (EU) dated December 11, 2000 from the resources of the European Development Fund of EUR 6 million.
- (c) Loan Agreement No. 7148-JM between the GOJ and IBRD dated October 31, 2002 to borrow US\$15 million.
- (d) Grant Agreement No. GA19/JM between the GOJ, JSIF and the CDB dated June 16, 2003 for funds totalling US\$2,866,897 under the Basic Needs Trust Fund fifth programme (BNTF) jointly funded by the CDB and CIDA.

### 1 **IDENTIFICATION (Cont'd)**

The Jamaica Social Investment Fund is a project and the company is the corporate entity which implements the activities of the project. The company receives funding, enters into contracts and pays expenses with respect to the project. The company neither earns any income nor incurs expenditure on its own account.

These financial statements reflect the assets and liabilities relating to activities carried out on behalf of the project and do not reflect the receipts or expenditure of the project. Separate financial statements are prepared to show project funding sources and expenditures.

### 2 SIGNIFICANT ACCOUNTING POLICIES

(a) Basis of preparation

The company's financial statements have been prepared in accordance and comply with International Financial Reporting Standards (IFRS).

These financial statements have been prepared under the historical cost basis and are expressed in Jamaican dollars.

(b) Accounts receivable

These comprise amounts which are expected to be settled within a year of inception and are stated at their nominal value.

(c) Cash and cash equivalents

For the purposes of the cash flow statements, cash and bank deposits comprise cash at bank and in hand and bank deposits having an original maturity of three months or less.

(d) Accounts payable

These amounts are stated at their nominal value.

(e) Net resources for project expenditure

These represent the unused balances of loans, grants or other financing received which have not yet been utilized in the JSIF project at the reporting date and for which the company would therefore have an obligation to justify their use subsequently in project activities.

### (e) Net resources for project expenditure (Cont'd)

These are recognized at their nominal amount adjusted for advances disbursed and contractual claims against the funds.

(f) Foreign currencies

Transactions in foreign currencies have been converted to Jamaican dollars at the rates of exchange ruling at the dates of those transactions. Assets and liabilities denominated in foreign currencies are translated to Jamaican dollars at exchange rates current at balance sheet date. All exchange gains and losses arising in the financial period are credited to, or charged against, Government of Jamaica resources, in the financial statements of the Project.

(g) Financial instruments

Financial instruments include contracts that give rise to both financial assets and financial liabilities. Financial assets include cash bank deposits, advances and deposits receivable. Financial liabilities include project expenditure reimbursable to GOJ and other funding agencies, net resources for project expenditure and accounts payable.

(h) Use of estimates

The preparation of financial statements in conformity with IFRS requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent liabilities at the date of the financial statements. Actual results could differ from the estimates and any adjustments that may be necessary would be reflected in the financial period in which actual results are known.

### 8 **FINANCIAL INSTRUMENTS**

(a) Fair value

Fair value amounts represent estimates of the consideration that would be currently agreed upon between knowledgeable, willing parties who are under no compulsion to act and is best evidenced by a quoted market price, if one exists.

The fair values of the company's financial assets and liabilities included in current assets and liabilities are assumed to approximate their carrying value, due to their short-term nature.

(b) Interest rate risk

Interest rate risk is the risk that the value of a financial instrument will fluctuate due to changes in market interest rates.

Interest bearing financial assets are primarily represented by bank deposits which are materially contracted at fixed interest rates for the duration of the term. At March 31, 2005, financial assets subject to interest aggregated to approximately \$46,159,121.

There are no interest bearing financial liabilities at March 31, 2005.

(c) Credit risk

Financial instruments contain an element of risk that the other obligators may be unable to meet the terms of agreements. Direct credit risk represents risk of loss resulting from the obligators' default in relation to assets on the balance sheet.

In respect of the bank deposits, the company minimizes this risk by seeking to limit its obligators to creditworthy entities.

Management policies require contractors for civil works to provide performance bonds and/or bank guarantees in respect of performance of these contracts. Procurement and selection procedures also evaluate the credit risk of potential contractors.

The maximum exposure to credit risk is represented by the carrying amount of each financial asset.

### 9 CONTINGENCIES AND COMMITMENTS

(a) At March 31, 2005, outstanding claims against the company made by two contractors on JSIF Projects aggregated approximately \$4 million in respect of contract payments and interest thereon.

In respect of one claim for approximately \$3 million, the adjudicator awarded settlement of \$312,615 in January 2003 to the contractor and the amount was paid in February 2003. The contractor refused to accept payment and referred the matter to an arbitrator. However, after a preliminary hearing the attorney of the contractor did not deliver the points of claim on the required date.

In respect of the other claim for approximately \$1 million, subsequent to March 31, 2005, the Arbitrator scheduled the hearing for June 15 and 16, 2005.

(b) At March 31, 2005, commitments in respect of contracts approved by the board but not yet executed amounted to approximately \$56 million.
