FRANKLYN TOWN POLICE STATION CONSTRUCTION - FRANKLYN TOWN, KINGSTON (#073334)

The scope of work includes, but is not limited to the construction of a lobby, CIB office, interview room, briefing room, training/resource room, office lounge, kitchen/canteen, barrack rooms and bathrooms etc. *Construction period is six (6) months.*

Bids MUST be accompanied by Bid Security in the amount of Four Hundred and twenty Thousand Jamaican Dollars (J\$420,000.00).

Lot 2:

SPANISH TOWN POLICE STATION EXPANSION AND REHABILITATION - ST. CATHERINE (#073328)

The scope of works includes but is not limited to the rehabilitation and expansion of the cell block at the Spanish Town Police Station. *Construction period is six (6) months*.

Bids MUST be accompanied by Bid Security in the amount of Four Hundred Thirty Thousand Jamaican Dollars (J\$430,000.00).

Lot 3:

FOUR PATH POLICE STATION EXPANSION AND REHABILITATION – FOUR PATH, CLARENDON (#073330)

The scope of work includes but is not limited to the construction, expansion and rehabilitation of the main **Administration Building** which will include: upper level offices, computer room, training/meeting room and kitchen and lower level administration area. General rehabilitation to bathrooms, electrical wiring and parking areas. **Cell block**: Rehabilitation of sanitation facilities, existing sewage disposal system, electrical wiring and painting. **Barracks Building:** Rehabilitation of barrack rooms, kitchen and lunch room etc. **Construction period is six (6) months**

Bids MUST be accompanied by Bid Security in the amount of Four Hundred Thousand Jamaican Dollars (J\$400,000.00).

LIONEL TOWN POLICE STATION EXPANSION AND REHABILITATION - LIONEL TOWN, CLARENDON (#073320)

The scope of works includes but is not limited to the general rehabilitation of the existing administrative building and barracks. This will include works to the lobby and office areas, rehabilitation of rest rooms, construction of a lunch room and laundry facilities, general painting and security fencing. *Construction period is six (6) months.*

Bids MUST be accompanied by Bid Security in the amount of Four Hundred Thousand Jamaican Dollars (J\$400,000.00).

Lot 5:

CENTRAL VILLAGE HEALTH CENTRE EXPANSION AND REHABILITATION - CENTRAL VILLAGE, ST. CATHERINE (#073362)

The scope of works includes but is not limited to the construction of consultation rooms, dressing room, sterilization room, laundry room and the rehabilitation and expansion of nine (9) existing spaces to allow for increased capacity. *Construction period is six (6) months.*

Bids MUST be accompanied by Bid Security in the amount of Four Hundred Ten Thousand Jamaican Dollars (J\$410,000.00).

Bidding will be conducted in accordance with tender procedures and guidelines specified in the Grant Contract **FED/2013/024-834** External Actions of the European Community – Contract Award Procedures of the European Community.
